This year Tuesday, June 19, polls in the various regularly established precincts, open 9 a. m. Ballots prepared by to 4 p. m. county auditors and sent to all precincts 5 days before election. PETITIONS

For county or district office must contain the names of at least 5 per cent of the total vote last cast for same office by party with which candidate affiliates.

SIGN BUT ONE PETITION. Each signer shall sign but one

paper for the same office.

FILING OF PETITION

County or district office, with county auditor not earlier than May 20, nor later than May 30, Legislative assembly, not ear-lier than May 20 nor later than

June 3.

FEES

State senator, \$30; member house, \$10; county auditor, 2 per cent of annual salary; sheriff, same sum as paid by auditor; treasurer, register of deeds, clerk of court, state's attorney, county judge, and superintendent of schools, each 2 per cent of annual sa'ary; public adminis-trator, \$5; county commissioner, coroner and surveyor, each \$3; constable and justice of the peace, each \$1. Delegates to state convention not required to pay any fees.

APPORTIONMENT

Apportionment of delegates to state convention for each county to be made by state central committees prior to May 1, and certified to county auditors, and by him included in notice to be pub-

ing two or more counties respec-tive auditors meet at office of auditor of senior county within 15 days after primary election (June 19) and compare votes and the senior county auditor shall immediately certify the nominations to secretary of state. Vaof the committee men from the various counties comprising the districts. Where two or more legislative districts are in one, fee to each county.

NOTICE OF PRIMARY ELECTION

Between April 1 and May 15 the secretary of state shall noti-fy each county auditor of the of-ficers to be nominated and the respective county auditors shall cause notice of same to appear for four successive weeks in the newspapers of the county.

CANVARS OF VOTES

The judges of primary election shall canvass the vote, preserve the list of names of voters and file same, one copy with board of registration. COUNTY CANVASSING BOARD

Comprised of clerk of district court, county auditor, chairman board of county commissioners and chairman of the central committee of the two political parties casting the highest vote for goyernor at the preceding election. CITIES EXEMPT.

Cities of less than 5,000 inhabitants are exempt from provisions of the primary law for the nomination of municipal officers

COUNTY CENTRAL COMMITTEE. Between August 1st and 10th the delegates elected to the state convention shall meet at the yarious county seats, at a time and place to be designated by the chairman of the county central committee, and elect a county central committee, of which commirtee no candidate shall be eligible. Every member shall be a legal voter and said committee shall meet within five days and elect chairman, secretary and treasurer from among their own members. Vacancies filled by majority of committee.
