## COMMISSIONERS' PROCEEDINGS

It was moved, seconded and carried that the petition of Robert I. Thorn for the correction of an error in the payment of taxes be approved, the same having been paid on lands to which the petitioner have neither title nor interest.

A representative from the agricultural college appeared before the Board and pleaded the advisability of appointing a County Agent. After having heard the statement of the representative and the proposition in connection therewith, it was taken under consideration by the Board. It was moved, seconded and carried unanimously, that the proposition be turned down.

The Board then proceeded to check in the several offices.

On motion the Board adjourned to meet April 7th, at 9 o'clock.

The Board met pursuant to adjournment; present Commissioners Pritz, Mogaard, Hazard and Hilstad.

On motion the bill of C. E. Peterson for printing was allowed for \$17.45.

The following depository bank bonds, having been approved by the States Attorney as to form, was on motion, seconded and carried approved by the Board as to sufficiency. The First National Bank of Binford in the sum of \$15,000.

The First National Bank of Coopers-

town in the sum of \$40,000.

State Bank of Revere, Revere, in the sum of \$6,000.

Farmers & Merchants Bank, Coopers-

town, in the sum of \$30,000.

The County Commissioners then proceeded to finish up the checking of the following offices to-wit: Auditor, Treasurer, Register of Deeds, Clerk of Court and Sheriff; and all were found correct.

A communication from T. R. Atkinson, relative to the classification of land, was on motion laid upon the table.

It was moved, seconded and carried that the sum of \$150 be set aside for each township, to be paid out of the Road Maintenance Fund, to be used for road dragging purposes, the same to be under the supervision and to be accounted for by the Commissioner for that district.
