The Dazey Commercial gives the collowing account of the project:

The plan is as follows: A stock company will be organized to build The plan is as a concerning to the high tension line from the corporate limits of Valley City to the village limits of each of the three towns which will be served. Each town is to build its own lines within town is to build its own lines within the corporate limits. These lines are to be leased by the company owning the high tension line and the patrons will be served by this company. The company has agreed to pay the villages an annual rental for their lines sufficient to take care of the interest on the bonds or warthe interest on the bonds or war-rants issued to construct the lines and also retire the said bonds or warrants in a period of twinty years. Thus it will not cost the taxpayers of the villages a single cent in excess taxes. the interest on the bonds

The rate which will be charged to the patrons will be 15 cents per kilowatt for lighting purposes and a power rate with a sliding scale down to eight cents per kilowatt. This is from three to ten cents per kilowatt cheaper than the rate which is charged by any of the small is being to 'n lighting plants near here and in ad-dition we will have the advantage of twenty-four hour service while most of the small towns do not have an of the small towns do not have any service except at night and many of them have service only for a few hours each night. The service which we will have will be exactly the same as that had by Valley City residents.

While Dazey is to be the end of ve any we will have will be exactly the same as that had by Valley City residents. While Dazey is to be the end of the high tension line according to present plans, it is by no means the end of the possible future construction of the company. The company will be organized with a capital stock of \$50,000.00 and it is the intention of those promoting the deal that as soon as the Sanborn-Rogers-Dazey line has been completed and the service started that extensions he service started that extensions vill be built to other nearby towns is soon as a demand for electricity will be built to other nearby towns as soon as a demand for electricity in those towns is received. And it is no remote possibility but a very near probability that within ten years every hamlet in the county of Barnes and practically every farm as well will be enjoying real twenty-four hour electric light service with Valley City as the distributing center.

Since Monday evening, Mr. Stee and Mr. Schmidt have visited each of the towns and are drawing up plans and specifications for each town, showing where the lines within the village limits will need to be located.
