ed. For two terms she has made the county an excellent official and the people will no doubt endorse her work at the polls November 8th. Don't forget to place an X after her name November 8th.

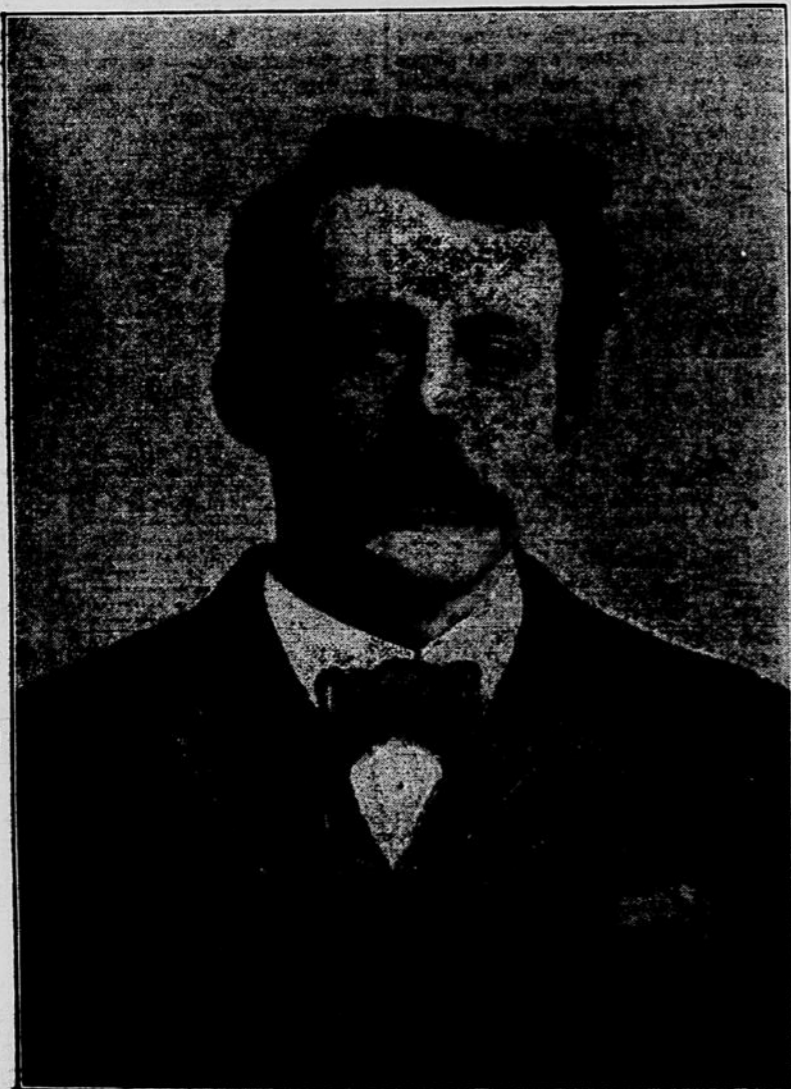
*Vote for Seval Friswold for treasurer.*

**DR. M. D. WESTLEY.**



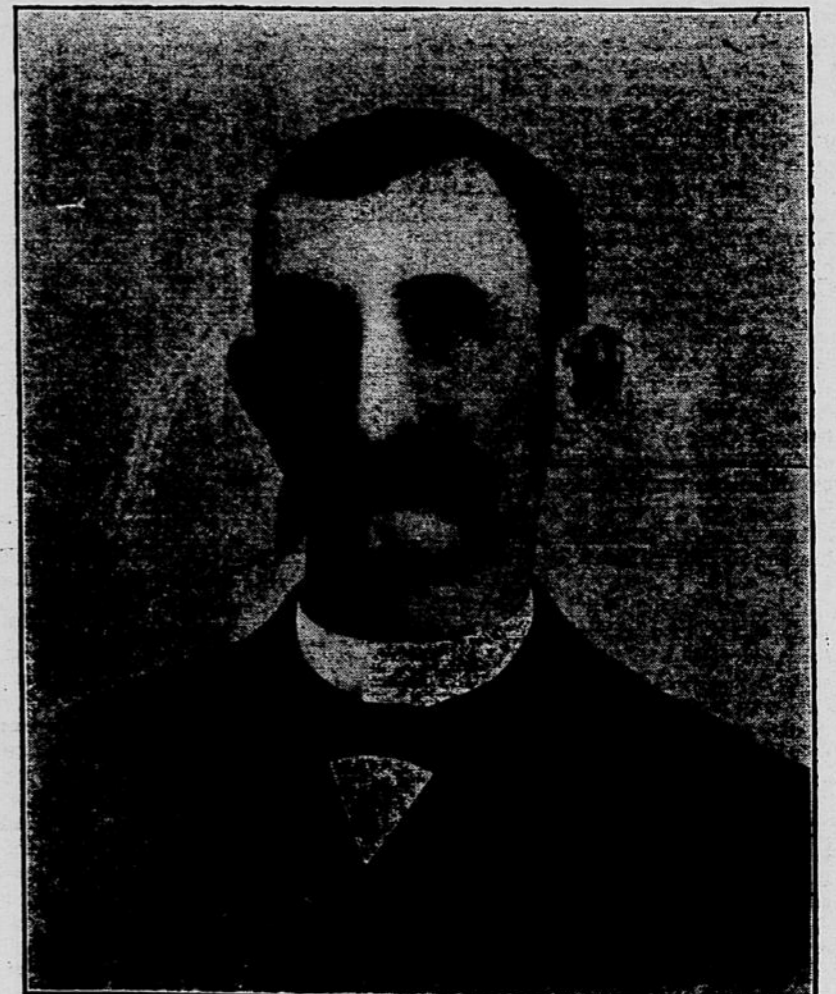
