
The fight for the speakership of the North Dakota house of representatives does not seem to warm up very much. It is said that Senator Judson LaMoure has concluded to give it to Representative Richmond of Benson county. This makes it easy for the members of the house.

The Mandan Pioneer says that the primary election, reformers. of this state want candidates for state offices to be nominated by direct vote. In Minnesota where they have a primary election law that foisted Mayor Ames on Minneapolis, most of the sensible people are fighting against the principle of having the state officials named by direct vote. The contention there is that while a direct vote might work well in a county where the voters know the individual candidates, it would not work well where the voter cannot know the candidates for state offices, many of whom live hundreds of miles away.

The LaMoure Chronicle remarks as follows: "It would have been difficult to crowd a greater number of misstatements and inconsistencies into so short a paragraph. In the first place, The Chronicle denies that "most of the sensible people of Minnesota are fighting against the principle of having state officials named by direct vote." We assert that exactly the contrary is true, and that most of the sensible people of Minnesota want the system expanded and made to conform to the Wisconsin system. Had the Minnesota law covered state offices, Bob. Dunn could not have been nominated governor by corporation influence and money, and the republican party would have been spared a humiliating and costly defeat. But when the Pioneer refers to the "best peopie" of Minnesota it doubtless has in mind that class of professional politicians who live by their wits-the people of North Dakota are gradually becoming acquainted with the

Again, note the alleged objecttion that it would not be safe to
allow the people to vote directly
for candidates for state offices,

miles away," while in the same
sentence the law is held up to
scorn because it foisted Mayor
Ames on Minneapolis! The
Chronicle would rather entrust
the selection of state and congressional candidates to the
whole people than to machine
politicians in a "cut and dried"
convention farce.

The Chronicle very well understands that argument avails nothing in the case of men like Tuttle, whose opposition to any system of reform that will weaken the grip of the political bosses is accepted as a matter of course. But it is a pleasure, sometimes, to puncture their hollow pretenses and expose their shams.
