Killed by Lightning. On Sunday morning about 2 o'clock Frank T. Neal, brother of Lemuel C. Neal, of this city, was struck by lightning at his residence five miles north of Ojata, and instantly killed. He had been sitting up with his wife, who had given birth to a daughter three days before, and had just lain down on a pallet on the floor. Beside him, and lying on BURRELL AVENUE, his arm, was his three-year-old daughter, who it was feared was fatally injured, but after a day or two recovered consciousness and is now apparently all right. The lightning came through the stove pipe hole in the roof, dropping on the floor as a ball of fire and exploded with violence, shattering the windows, walls, an organ and some other articles. Mrs. Neal called to her husband, and receiving no answer, sprang from the bed to his side. Her screams brought out the hired man, and every effort was made to bring the dead man to life, but

Lightning struck the Commercial hotel in this city, killing two persons, shocking a number of others more or less severely, and slightly mjuring the building. The bolt seemed to have come down the chimney and branched out upon the various stove pipes. One of the killed was James Byrnes. He was standing near the bar in the saloon, and was thrown to the floor in a heap with four other men, none of the others being seriously injured. Byrnes was killed instantly, a slight trembling being the only sign of life discovered.

The other victim was Jane Larsgard. a young lady about 18 years old, employed in the house, who when struck, was seated in the kitchen. She also was instantly killed. Her people reside at Grand Harbor and have been telegraphed, and a sister is employed at the Elk Valley Farm.-Larimore Pioneer.
