Official Paper of Griggs County

Proceeding at the Mayville Convention.

Convention called to order at 2:30
by the chairman of the central commit-
tee, L. Thompson, who read the call, and
on motion Dr. Kerr of Griggs county
was elected temporary chairman of the
convention, and E. L. Smith of Traill
county, secretary.

On motion J. C. Smith, of Steele
county, was made second secretary.

On motion, I. W. Chantland, of Traill,
Jos. Buchheit, of Griggs, and S. Axdahl,
of Steele, were made committee on cre-
dentials.

The representatives of the press were
granted room at the secretary's table.

On motion, a committee of three was
appointed by the chair, for permanent or-
ganization: Stevens, of Griggs, Ander-
son, of Steele, and Bowers, of Traill.

A committee of three, were appointed
to draft resolutions.

C. H. Newton, of Steele, Col. Plummer,
of Traill, and C. A. Hunter, of Griggs.

The committee on credentials, report-
ed no contests, and all parties who had
presented credentials, claiming seats in
the convention, entitled to them; which
report was accepted.

On motion, committee on temporary
organization, was made permanent.

The convention proceeded to nomi-
nate one councilman, and two representa-
tives. Geo. E. Bowers of Traill pre-
sented J. F. Selby, for the council, Jos.
Buchheit, of Griggs, presented F. H.
Adams, for the house, Col. W. C. Plum-
mer, of Traill, presented the name of O.
G. Majors, for the house, S. G. Ander-
son named D. W. Sprague, of Steele.
Messrs Selby and Adams, were nomi-
nated by acclamation.

The committee then proceeded to
take an informal ballot on D. W.
Sprague and O. G. Majors, both of
Steele county, for the house, D. W.
Sprague received 17 votes, O. G. Majors
received 10 votes.

D. W. Sprague, was then nominated
by acclamation.

On motion, a committee of three were
named by the chair, to inform the can-
didates of their nomination by the con-
vention—Committee, Geo. E. Bowers,
T. G. Anderson, and Jos. Buchheit.

The committee on resolutions, then
made their report, which was accepted.

On motion, of G. E. Bowers, resolu-
tions were amended by striking out the
part referring to the liquor question.

The central committee appointed by
the chair are, Traill county, G. W. Gris-
wold, L. Thompson, Gunder Howard
Peter Herbrandson, Steele, S. J. Axdahl,
J. O. Smith; and Griggs, J. Stevens.

The membership of the convention
was as follows:

Griggs County—Dr. T. G. Kerr, C.
Hunter (2 proxies), Joseph Buchheit,
Juhus Stevens.

The Aberdeen Conclave.

The names of Day, Maratta, Benton
and Johnson, were put in nomination,
Day being elected on the first formal
ballot by a plurality of 165 votes.

After passing resolutions thanking
everybody, the convention adjourned
sine die. Most of the delegates departed
for their homes this morning, and the
remainder will go to-night. The anti-
divisionists were defeated at every turn
they made from the resolutions to the
naming of the central committee.

The ballot was as follows:

D. M. Day..... 228
L. G. Johnson..... 47
D. W. Maratta..... 15
No. of votes cast..... 351
Necessary to a choice, 176.

M. H. Day is a conscientious pains

taking and efficient democrat. He spent
much of the first year after Mr. Cleve-
land's inauguration, in Washington and
worked conscientiously for the welfare
of his party—he is fully as able a states-

put on any airs.
