I, Knud Thompson, Treasurer of Griggs County, Dakota Territory, do hereby certify that the annexed list of real property has become delinquent by reason of non-payment of taxes for the year A. D. 1886 and will be sold, with the penalty and interest, advertising and all other costs accruing thereon, as provided by statute, together with costs of sale, commencing on the first Monday of October next, being the 3rd day of October, A. D. 1887, between the hours of 9 o'clock a. m. and 4 o'clock p. m., continuing until all have been offered for sale, at my office in the courthouse, in the village of Cooperstown, county of Griggs, and Territory of Dakota.

The second column of figures following denotes the township. The third column of figures, following, denotes the range. The fourth column of figures, following, denotes number of acres. The fifth column of figures, following, denotes the year. The sixth column of figures, following, denotes the total tax.

In the schedule of town property— The first column denotes the lot. The second column denotes the block. The third column denotes the total amount of tax. S. or Sec. means section. T. or Tp. means township. R. means range. Bk. means block. Ne. x means northeast quarter. Nw. x means northwest quarter. Se. x means southeast quarter. Sw. x means southwest quarter. N. x means north half. S. x means south half. E. x means east half. W. x means west half. "Do" signifies that description or number is the same as in the preceding entry directly above. Amt. signifies amount. Lt. signifies lot. Qr. signifies quarter. Each town plat in which lots are taxed has its distinctive head line.
